We will then hire a drywall finisher to do the plaster work.

- Plumbing schematics have been completed as part of the full drawing package for the Bathroom Remodel.
- Year end accounting has been performed for Boulder Dance.

Report of the Membership Committee REVISED 2/2/2012

- 1. The position of Membership Chairman should be created. Larry Utter has volunteered. The duties of this position should be:
 - 1. Keep an accurate record of all members, both individual and group. This includes not only who is a member but also contact information (email and physical address) to facilitate communication.
 - 2. Send the yearly renewal reminders
 - 3. Communicate regularly with members, both individual and group. This specifically includes announcing the Annual Meeting and the results to the membership. Other communications could address the build out of the Avalon, Board news, the importance and benefits of membership, the need for bequests.
 - 4. And other duties to be determined
- 2. Individual Members
 - 1. Individual Memberships are based on the calendar year and can be bought any time during that year (including the day of the Annual Meeting).

2. Rates should be increased (actually aligned with rates already in STOMP) and other donation levels created:

Friend \$15
Family \$25
Supporter \$50
Contributor \$100
Patron \$500
Angel \$5000
Legacy Contact VAC

- 3. Benefits:
 - * Support of the local dance community and Avalon
 - * Voting rights at Annual Meeting as stated in the Bylaws
 - * STOMP delivered by USPS mail if desired (must opt-in)
 - * Thank you letter from Board
 - * All members should be listed in STOMP at the end of the year (December)

3. Groups

- 1. Groups are needed for the vitality of VAC, source of future leaders, and needs of groups will carry the VAC into the future.
- 2. Memberships are based on the calendar year.
- 3. Different rates should be applied to different sizes of groups:

0 - 500 attendees per year \$25 500 to 2500 attendees per year \$75 greater than 2500 attendees \$200

4. There will be a statement on Group membership form to the effect: Membership dues are used to defray the operation of the VAC including the web page and STOMP

5. Benefits

- * Use of the VAC web site (non-groups should not be allowed use)
- * Listed in STOMP calendar, ** should non-members be listed at all **
- * Listed as a Member Group in STOMP
- * Voting rights at Annual Meeting / representative at Annual Meeting
- * Priority rental consideration at Avalon
- * Preferred member rate?? Chuck suggested that any regular, repeating group should just be required to be a member.
- * Can perform at International Festival
- * Possible joint advertising in future
- * Possible insurance in future
- * Thank you letter from the Board
- 4. VAC should be synonymous with Avalon, i.e. when one thinks of the Avalon, they should also think of the VAC. Dancers at the Avalon do not currently associate the two.
- 5. Look into insurance again. Susan will look into the NFO policy.
