MINUTES: BDC BOARD MEETING 05-04-23, held via Zoom. President Larry Utter called the meeting to order at 6:30PM.

APPROVAL OF MINUTES: 04-06-23. Motion – Bob; 2nd-Heather. Motion passed.

STANDING REPORTS

TREASURER: Glenn - BDC Checking – \$19,260 ; Avalon – \$26, 888; Schwab Total – \$949,859; Schwab Cash – \$109,514. Glenn filed an employee retention credit offset by PPE loans forgiven. About \$47,000 coming back to us. A revised quarterly filing.

AVALON MANAGEMENT COMMITTEE: Caroline – working on same projects – creating space for all our groups. And a sign out front below the Avalon sign. Flags will be concreted into ground.

AVALON: Chuck – Still working on a new tenant for the vacated space. Work on ballroom continues, met with architect. Got in line for stage façade completion. Property has been reassessed at 3M more than past, so taxes will increase. We may look into BDC owning the property to decrease taxes. Narcan box is on wall, and Narcan stocked.

MARKETING: Heather – not met in a while. Banners are getting great feedback. TV is good. Improved our FB presence due to Bob, and on other social media. Website – Chuck – Nestor, Bob and Chuck worked on. It's messy. Proceed at an hourly rate on updating. Glenn & Heather working on flier to succinctly show what we offer here, a QR code, will disseminate. We need a graphic artist. Decided newspapers and free week not worth the investment. Country Western dance – Joseph Snowhawk is thinking of it.

BUSINESS

PLAN ANNUAL MEETING: Directors for election: (ballot sample sent with agenda) – Steward Hartman, Chuck Palmer, Caroline Stepanek, Dorothy Vernon.
